BE IT FURTHER RESOLVED, that no Board of Education member or employee of the school district shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board. Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent and his designee are hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold the department heads responsible for performance of their responsibilities within the amount appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

This appropriation act resolution is to take effect on approval by Board of Education.

RATIONALE: In preparing the 1st amended budget, the administration has reviewed the entire budget and updated the budget to reflect current information. Projected revenue increases from \$134.7 million to \$136.8 million dollars while projected expenditures decrease from \$137.8 million to \$136.4 million. The changes result in revenues exceeding expenditures by \$0.4 million compared to expenditures exceeding revenue by \$3.0 million in "Original Budget" and a \$3.4 million positive budget impact.

Three major changes to the budget accounted for the vast majority of the \$3.4 million positive variance:

- Blended enrollment 124.43 FTE higher than original budget (+\$867,000)
- Health/Dental insurance better than current illustrative rates (-\$1,411,241)
- Retirement composite rate reduced from 26.78% to 24.56% (-\$1,760,656)

All other net revenue and expenditure changes were a net negative variance total of \$500,283.
