The Board has considered all of the evidence presented at the hearing, and based on the evidence, has reached the following conclusion: Student, 10/21/13:IROQ01 was guilty of Section IV 10. *"Verbally threatening a staff member associated with the District."*

Therefore, it is resolved that Student 10/21/13:IROQ01 is permanently expelled from the Chippewa Valley School District. Student 10/21/13:IROQ01 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function. Ayes, all. Motion carried.
