# **From The Community**

- Superintendent Ron Roberts welcomed and addressed the community members present regarding the impact of the tragic loss of one of our students in November. Superintendent Roberts emphasized Dakota High School will continue to provide counseling to students and staff who were affected by this. Crisis teams are available and in place for as long as necessary. Superintendent Roberts also spoke on how Chippewa Valley Schools is working and partnering with Macomb Township and Macomb County officials to make the necessary changes to ensure the safety of our students.
- Community Members, Danielle and Randy Leedy spoke about their concerns for the traffic safety surrounding 21 Mile Road and Heydenreich.
- Dakota High School parent, Amber Markel, spoke about her concerns with the traffic safety for the kids walking, riding and traveling to school in the area of 21 Mile Road and Heydenreich.
- Community member, Kenneth Rhoades, addressed what he believes to be dangerous conditions on Heydenreich road.

 Board of Education President, Frank Bednard, read a statement on behalf of the Superintendent and Board of Education personally thanking the community for their attendance and the feedback provided and assured the community that the district shares their concerns.
