- 6 2019 Thomas Saf-T-Liner C2 77-passenger school buses with 2 rows each of integrated child restraint seats at \$92,488.00 each.
- 2 2019 Thomas Saf-T-Liner C2 65-passenger school buses w/integrated child restraint seats, front lift at \$96,542.00 each.

The total for this purchase would be \$936,034.00.
