G.1 <u>Approve Revision to Board Policy #2260/Nondiscrimination and Access to</u> Equal Educational Opportunity Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the revision of board policy # 2260/Nondiscrimination and Access to Equal Educational Opportunity and that the reading of the policy be waived."

RATIONALE: This policy was revised to include language regarding sexual orientation and transgender identity. The U.S. Department of Education is particularly concerned with this issue and how students may be subjected to bullying based upon their sexual orientation or transgender identity.

Additionally, the policy was revised to include language regarding equal access to school facilities/premises for the Boy Scouts of America or other Title 36 youth groups as required by the Federal Boy Scouts of America Act. This revision reflects the current state of the law and should be adopted to maintain accurate policies.

G.2 Approve Revision to Board Policy #5722/School Sponsored Publications and Productions Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the revision of board policy # 5722-School Sponsored Publications and Productions and that the reading of the policy be waived."

RATIONALE: The revision of this policy outlines the specific rights of district administration to oversee student publications/productions and provides consistency to the process.

G.3 Approve Adoption of New Board Policy #8462/Student Abuse and Neglect Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve new board policy # 8462/Student Abuse and Neglect and that the reading of the policy be waived."

RATIONALE: This new board policy requires employees to report any student abuse or neglect and should be adopted to be in compliance with laws.

G.4 Approve New Board Policy #1613 & Revisions to #3213, #4213/Student Supervision and Welfare Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve new board policy #1613/Administration and revisions to board policies #3213/Professional Staff and #4213/Support Staff-Student Supervision and Welfare and that the reading of the policies be waived."

RATIONALE: The new policy #1613 provides specific guidance for administrators and should be adopted. The revisions to current policies #3213 and #4213 address social interaction with students through online social networking sites and the responsibility of school staff to maintain an appropriate relationship and appropriate boundaries with students.
