Therefore it is resolved that Student 04/14/14:DAK02 is expelled from the Chippewa Valley School District from April 14, 2014 through July 1, 2014. Student 04/14/14:DAK02 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function during the duration of the expulsion. Ayes, all.
