G.4 Approve Bid Award for Virtual Desktop Infrastructure

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education award a contract totaling \$5,551,926.28 to Data Strategy for the Virtual Desktop Infrastructure, Server Virtualization, Backup and Windows Migration project, Bid Package 10-T06."

RATIONALE: The project is in lieu of district-wide student computer replacements and includes hardware and software to virtualize 3,000 concurrent desktops as well as up to 100 servers. This new system will be platform for desktop and data center virtualization.

This information was reviewed with the Building & Site Sub-Committee on Monday, May 7, 2011 and funding is available within the 2010 Building & Site Funds.

G.5 Approve Purchase of Novels & Educational Materials Mr. Sederlund

RATIONALE: Aggressive pricing was obtained through the public bidding process RFB 15.1112.

The proposals were reviewed and approved by Educational Services and Purchasing Departments. Funding will come from the General Fund for this purchase.

G.6 Approve Revision to Board Policy #7540/Computer Technology and Networks Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the revision to board policy #7540/Computer Technology and Networks and that the reading of the policy be waived."

RATIONALE: The 21st Century online environment requires competent use of social media sites to establish relevant communication with a wide audience. Through CIPA, the Children's Internet Protection Act, training for all students in appropriate online behavior, safety and security is required. Use of Social Media in the classroom requires the adoption of this policy, which defines and outlines expectations for staff and students using these tools via the District's network.

G.7 Approve Adoption of Board Policy #7540.03/Student Network and Internet Acceptable Use and Safety Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the adoption of board policy #7540.03/Student Network and Internet Acceptable Use and Safety to fulfill the requirements of the Children's Internet Protection Act amended in 2011 and that the reading of the policy be waived."

RATIONALE: In August 2011, the Federal Communications Commission amended the Children's Internet Protection Act to include new regulations requiring the following commitments from all school districts:

- 1. The education of minors using age-appropriate curricula about appropriate online behavior including interacting with other individuals on social networking websites and in chat rooms, and cyber bulling awareness and response;
- 2. The monitoring of online activities of minors;
- 3. The utilization of a technology protection measure for minors and adults

By adopting the board policy, along with use of the Acceptable Use Policy and newly created Student Internet Safety Contracts, the District has shown its compliance to the law before the required date of June 30, 2012.

G.8 Approve District Technology Plan for 2012-2015

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the Chippewa Valley Schools Technology Plan for the years 2012 through 2015."

RATIONALE: A valid Technology Plan is not just best practice, but it is also mandated by state and federal programs. It is necessary to receive e-rate discounts on telecommunication fees.
