

# Noodles & Company opens Monday in Macomb Township

A new Noodles & Company restaurant will celebrate the grand opening of its second location in Macomb County and has plans to hold a fundraiser for Chippewa Valley Schools next month.

Pasta Per Trio, a Grand Rapids-based restaurant investment group, is bringing the fast-casual eatery chain to the county. The new location is at 15575 Hall Road, east of Hayes Road in Macomb Township.

Serving “noodles and salads inspired from around the world,” the menu contains a variety of noodle-based dishes, salads and sandwiches.

“We are excited about our opening in Macomb and the opportunity to become a strong partner in the community,” Mike Endres, marketing director for Pasta Per Trio, said in a news release.

Endres said Noodles & Company’s menu features Asian, Mediterranean and American noodles. Favorite items include the sweet and spicy Japanese Pan Noodles, creamy Penne Rosa, Wisconsin Mac & Cheese and spicy Korean Beef Noodles.

There also are buttered noodles, pad Thai, spaghetti & meatballs and whole grain Tuscan fresca. Other menu items include soup, kids meals salads and sandwiches ranging from spicy chicken Caesar to BBQ pork.

Within five minutes of ordering lunch or dinner, diners will have their food delivered to the table with real silverware, according to the news release.

There will be carry-out and online ordering.

The restaurant has 35 employees and four managers, according to Endres.

Community involvement is also important, Endres said. As part of their grand opening celebration, Noodles & Company will donate 50 percent of the day’s sales on Oct. 11 to support the Chippewa Valley Educational Foundation.

The nonprofit foundation’s mission is to help raise money for new programs by employing private resources and gifts to supplement traditional school funding.

“We believe Chippewa Valley Educational Foundation is such an important part of the community and we look forward to continued involvement with many local schools and other non-profit groups in the area,” he said in the release.

The Macomb Township location is Pasta Per Trio’s second eatery in Macomb County. Earlier this year, they also opened a Noodles & Company in Chesterfield Township. Pasta Per Trio has 20 restaurants in Michigan.

Endres said another eatery is planned for Macomb County in the future.

The new Noodles & Company opens at 11 a.m. Monday.
